

**Memorandum of Agreement
between
Lane Community College Education Association (LCCEA) and Lane Community College (LCC)
HB2611**

This Memorandum of Agreement (MOA) between Lane Community College Education Association (LCCEA) and Lane Community College (College), which concerns HB2611, shall be effective upon execution. All terms of the LCC-LCCEA Collective Bargaining Agreement and all associated Memoranda of Agreement remain in effect.

1. Part-time faculty who receive LCC-provided benefits and who are eligible for insurance under HB2611, SB1522, and/or SB551 shall have LCC automatically designated as their home institution unless they opt-out. Part-time faculty who begin to receive LCC-provided benefits under HB2611, SB1522, and/or SB551 shall have LCC automatically designated as their home institutions unless they opt-out.
2. LCC shall continue provide all the items outlined in #7 (b - h) and associated sub sections of 7(h) of the SB551 MOA as modified by the SB551 Modification MOA except as follows.
 - a. Beginning in Fall 2024, all new contracted faculty will receive a one course release for one term up to .333 FTE. This one course, one term release shall replace 7(vi).
3. LCC shall retain all the reimbursements from the state provided under SB551, HB2611, SB1522.
4. Funding in the amount of \$40,000 (i.e., from 7(g) and 7(h)vii) of the SB551 MOA shall be transferred to FPD each year (per Spring 2023 agreement).
